1) WATER QUALITY MONITORING. QBC LOCATES, REMOVES, AND REPLACES QUAHOG BAY'S ANTIQUE  
SEWAGE SYSTEMS.

2) POLLUTION REMEDIATION. QBC OFFERS FREE ON-CALL PUMP-OUT SERVICE TO ANY BOATS  
ANCHORED IN QUAHOG BAY, THUS PREVENTING POTENTIALLY THOUSANDS OF GALLONS OF BROWN AND
